**Clarification of News Report**

We respond to the request of the Philippine Stock Exchange ("PSE") for clarification in connection with the news article entitled "Doris Ho's relatives catch mining fever, plans nickel venture in Mindanao" published in the 20 November 2017 issue of The Philippine Star.

The article reports:

"A number of cousins of conservation advocate and shipping heiress Doris Magsaysay-Ho apparently plan to undertake some serious excavations in the mountains of Mindanao.

According to NiHAO Mineral Resources International, the listed mining venture now controlled by stockbroker Jerry Angping and a Taiwanese partner, the firm is 'exploring the possible sale' of its nickel mining claims in Misamis Oriental to the Magsaysay Group of Companies.

According to the grapevine, Ho's cousin, Cesar Magsaysay who used to be married to a Roa, is the Magsaysay Group representative negotiating to acquire the NiHAO claims.

The planned sale of the nickel mining claims in Manticao, Misamis Oriental was apparently already reached advance stage, as the possible disposal has already been tabled by NiHAO for next month's shareholders' meeting. x x x"

NiHAO Mineral Resources International, Inc. (the "Company") hereby informs the Exchange and the public that the Company is open to any possible sale, joint venture, co-operation, co-production and any kind of partnership for development within the limits prescribed by law of its mining claims in Manticao, Misamis Oriental (the "Manticao Nickel Claims") covered by the Exploration Permit Application under the name of Bountiful Geomines, Inc.

To date, the Company continues to explore possible deals/partnership/sale over Manticao Nickel Claims with interested parties. However, discussions made by the Company with any of these interested parties have not reached an advance stage and the Company has not entered into a firm deal with any potential third party/buyer/partner.

The Company assures the Exchange and the trading public that any developments regarding this matter will be disclosure promptly.
